

## Preamble

This document describes the services contained in the OPEN! licences.

The GIREVE Services granted by an OPEN! licence are grouped in three categories: (i) Business Services, (ii) Roaming Services, (iii) Clearing Services. Each GIREVE's Service is identified by an identification number ("IDNo" in the tables below) and is further described in the document "GIREVE - OPEN! services description" with the same identification number.

In this document, the symbols have the following meaning:

- service is included in the OPEN! licence
- \* service is included in the OPEN! licence but is actually available with the Contracting Party's Partners having subscribed to this service on their side
- service is not included in the OPEN! Licence
- \* service is not available in the OPEN! licence at the time of the signature between the Parties but will be automatically included when the service is released by GIREVE
